Public Hearing for Pine St. opened at 6:16p.m.

The Road Comm. Will not do snow plowing on Pine St. The citizens that were present were not in favor of any dust control.

Motion by Helms seconded by Lewis to approve resolution #110409-4 to direct the assessor to prepare an assessment roll on Pine St. Roll call vote: Ayes; Helms, Bielby, Bassi, Holzheuer, Lewis. Nays: None. Motion carried.

Motion by Bassi seconded by Holzheuer to set a public hearing date for approval of the assessment costs to be levied for Ira Drive and Pine this will be November 18, 2009 at 6:00 p.m.
