Approval of the Agenda: Add item 12D Parades, Delete item 12A and add item 13B Historical Comm. Motion by Bassi seconded by Helms to approve the agenda as amended. All Ayes. Motion carried.

Approval of Minutes: Motion by Bassi seconded by Helms to approve the minutes of the Regular meeting of March 17, 2010, the Special meeting April 6, 1020 and the Special meeting April 10, 2010.. All Ayes. Motion carried.

Financial Report: All accounts are in balance.

Presentation of Bills: Motion by Helms seconded by Holzheuer to approve the bills as presented. Roll call vote: Ayes; Bassi, Bielby, Holzheuer, Helms, Lewis. Nays; None. Motion carried.

Public Comments 6:50 p.m. Mr. & Mrs. Bob Stevens gave a donation towards the purchase of a new flag pole for the front of the Township Hall. A new pole will cost between \$800 - \$1,300.

Gazebo Property Lease: Motion by Bassi seconded by Bielby to enter into an agreement with Independent Bank for the use of property for the Gazebo, a ten (10) year lease for \$1.00 per year. Roll call vote: Ayes; Bielby, Helms, Holzheuer, Bassi, Lewis. Nays; None. Motion carried.

Non-Statutory meeting pay: Motion by Helms seconded by Bassi to allow the Board of Trustees to be paid for Non-Statutory meetings. Roll call vote: Ayes; Bassi, Helms, Holzheuer, Bielby, Lewis. Nays; None. Motion carried.

Road Maintenance 2010-2011. Motion by Bassi seconded by Helms to approve the 2010-2011 Road Maintenance agreement with the Road Commission to do the following projects; Wilson Creek, North, East, South and West streets, Mill Station Rd, and Galion Rd (half this year and the rest next year. Approx. cost this year is \$190,000.00 Roll call vote: Ayes; Holzheuer, Helms, Bielby, Bassi, Lewis. Nays; None. Motion carried.

Dust Control Bids: The following bids were received; LCC \$59,105.00, Cramar \$59,400.00, Advanced \$54,000.00 and MCS \$53,460.00. Motion by Bielby seconded by Bassi to award the dust control bid to Advanced as this is the company we have been using. Roll call vote: Ayes; Bassi, Bielby, Holzheuer, Helms, Lewis. Nays; None. Motion carried.

Parades for 2010: Motion by Lewis seconded by Helms to approve a resolution for four (4) parades during 2010, Memorial Day, 4th of July, Iosco Co. Fair and Hale High School Homecoming. Roll call vote: Ayes; Holzheuer, Helms, Bassi, Bielby, Lewis. Nays; None. Motion carried.

Historical Comm.; Jerry Hewitt gave an update on the Commissions activities. They will be purchasing a computer and software.

Motion by Bassi seconded by Helms to adjourn at 7:40 p.m. All Ayes. Motion carried.
